The fisheries component of the UNEP/GEF South China Sea Project successfully developed the scientific, policy, and institutional foundations required to enable the establishment and operation of a regional system of fisheries *refugia* in the South China Sea and Gulf of Thailand. The management of the environment and fisheries in the region is highly fragmented and the *refugia* concept has contributed significantly to bridging the divide between fisheries and environmental managers in the region. The concept has provided a basis for a wider understanding of fisheries concerns by other sectors, and has sensitised the environment sector to the need to consider fisheries in habitat or ecosystem based management.
