i. Application of Remote Sensing and GIS Techniques for Mapping of Coastal Ecosystems and the Establishment of GIS-Database for Coral Management in the Coastal Waters of Phu Quoc Island, Vietnam. The project involves map making to perfect the detected algorithms on coral reef, sea-grass bed, mangrove and Melaleuca forests, building GIS maps of their distribution and capacity building programme for Cambodian personnel in mapping and establishment of database.

ii. Implementation of activities to strengthen capacity of local communities in coral reef conservation in Vinh Hai and Thanh Hai communes, Ninh Thuan Province, Vietnam

entailing awareness building on coral protection, enhancing capacity of volunteer teams on effective patrolling and support for alternative livelihood to the local communities.

iii. A review of previous projects on coral reef management that had been carried out in the recent past five years was carried out. It was aimed at determining their strengths, weaknesses and how they can become self-sustaining when there is no more assistance. The review involved a desktop study, analysis, evaluations and culminated in the COBSEA Regional Workshop on Coordinating Coral Reef Monitoring and Management in the Seas of East Asia, in May 2006 in Pattaya, Thailand.

iv. Development of the publication "Case Studies on Coral Reef Monitoring and Management Projects, 2004-2005.

i. The Green Fins programme to expand the network of environmentally-friendly dive operators that is being implemented in Thailand and Philippines.

ii. The Green Fins Workshop and Launch on 29-30 May 2007. In relation to the workshop a slogans contest opened to residents of the 10 COBSEA member countries and a field trip for selected students and journalists to build awareness about the Green Fins programme.

iii. Development of a metadatabase of coral reef projects beginning with COBSEA implemented projects with the cooperation of the UNEP/GEF South China Sea project.
