- Forestry Agency designated Mangrove forests at the estuaries of Urauchi River and Nakama River in Iriomote Island as Forest Ecosystem Reserve in 1991 to conserve wilderness condition.
- Agreement on Conservation and Use of Nakama River has been established under the Okinawa Prefecture in 2004 to prevent falling of mangroves by tourist boat.
- Ministry of the Environment has developed a rapid monitoring method on mangroves in 2006.
- Japan International Cooperation Agency (JICA) has conducted four projects on Mangrove conservation:
 - A. Project of Mangrove Information Centre in Indonesia (2001).
 - B. Project of Coastal Wetland Conservation in Yucatan Peninsula, Mexico (2003-2008),
 - C. Project of Participatory Integrated Management of Mangrove in Myanmar (2006-2011).
 - D. Project of Mangrove Information Centre in Oman (2006-2008).
